Mr. Joe Garret with Trebel (government aggregation consultants) concerning Electric Aggregation presented information concerning electric aggregation for our community. Aggregation is a plan to look for the best possible price for electric supplies. This company would bid on the price of electric supplied to our township to attain a lower rate than the regular average rate. Aggregation must be voted on by ballot. The trustees could then choose any consultant company to represent the township. If you go through Trebel, the trustees would have to sign a three year contract. In return, Trebel would handle all the paperwork, advertising, update websites, provide two mailings and hold public meetings.
