#### Fire Report:

Chief Holman would like permission to replace two vehicles this year.

- 1. A new 2014 Chevy Expedition Cost \$31,800. State bid from Statewide Lincoln. The current vehicle will be traded to the Police Department in exchange for the white unmarked vehicle which will be sold on Gov. Deals. Striping costs of about \$300.00.
- 2. A new 2014 Braun Medic Unit Cost \$130.000. Painting \$6,000.00. Striping \$500.00. This will replace the 1998 Medic Unit, which will be sold on Gov. Deals.
- 3. If striping costs go over budget, the Fire Association will cover the costs.

Motion to go ahead with the replacement of both vehicles at the costs stated by Chief Holman:

Chief Holman has applied for a grant for mounting a radio system in the new medic.

#### **Police Report:**

Chief Stitzel would like to reduce the number of Police Department vehicles. He plans to sell off two vehicles, and purchase one new cruise. He has not received any estimates at this time, then, he would trade the unmarked white vehicle to the Fire Department in exchange for their Expedition.

The concrete floor in the Police Department bay does not drain properly. Water runs into the bay towards the inside walls. If this continues, it will cause damage to the walls. Due to EPA regulation, a drain cannot be installed.

### **Maintenance Department:**

For 2014 the Maintenance Department will be looking to replace the older dump truck, and the lawn mower. Mr. Metzger stated they would also like to look into the possibility of either buying the backhoe from the McCombs family, or purchasing a used back hoe. The Trustees will check with dealers at the February Convention concerning the dump truck.

Mr. Bevan stated at this time, the Township currently owes for backhoe rental for tree work and grave openings/closings.

The Township Trustee and Township Fiscal Officer salaries are based on the annual budget of the Township, and the amount is set by the State of Ohio. There has not been a cost of living increase since 2008:

Motion to provide insurance as follows: Township Officers beginning terms in 2014 and beyond and any eligible employees may participate in any of the insurance benefits offered by the Township for medical, dental, and vision insurance. They may select from any health insurance plan, HRA, or other available "pick-up" or a "reimbursement" option during their term. The official or employee may select any available plan at the start of his or her term, or employment and change to a different plan if desired during the designated annual open enrollment period. The monthly premium costs for any plan type will be paid as follows: 95% of the premium shall be paid by German Township; the remaining 5% will be paid as a payroll deduct. No pick-up or reimbursement plan can exceed the maximum costs of the main health insurance plan offered by the Township (On November 12, 2013 insurance renewal rates were approved):
