A. Motion to approve the Minutes of March 08, 2016:

Hearing of the Public

Mr. John Rehm reported that the railroad track at Hominy Ridge Road was in need of repair. Mr. Clark stated that the trustees would take a look at it and report it to the railroad.

Fiscal Officer Report

Mrs. Griest presented the following:

- Approval of the costs \$2172.40 for the Banquet. (fire dept.)
- Renewal of the accident policy with McMann Smoot Riddle Agency cost \$3017.50 (fire dept.)
- Renewal of the service bridge annual SaaS Fee \$2150.00 (fire dept.)
- C. Motion to accept the financial reports and to approve the payments of all of the above:

- Due to high banking fees at Key Bank for the checking account, need to change banks. Mrs.
 Griest has spoken with both Wesbanco and PNC, and both are able to reduce the fees substantially. The Trustees must decide which bank.

Zoning Department

Mr. Degenhart was unable to attend today meeting due to a prior engagement.

Discussion concerning Rural King: They were having a good response and they are glad to be in our community. They also own the old Hobby Lobby store and have several businesses looking into leasing it. There were several fire violations, they are working on correcting those and have been great to work with.

Fire Department

Chief Holman reported the following:

• There will be joint active shooter training with the Fire Department, Police Department and the Clark County Sheriff's Department at the Upper Valley Mall.

Police Department

Chief Stitzel presented the following:

- The timers on the Township building outdoor lights do not seem to be working. The lights don't go off during the daytime. Have tried to reset them. As the bulbs go out they are trying to replace them with LED lights.
- Requesting an Executive Session at the end of today's meeting.
- Has obtained the title to the Dodge Charger forfeiture vehicle and would like permission to sell it on GovDeals.
- E. Motion to sell the Dodge Charger forfeiture vehicle on GovDeals:

Mr. Metzger asked Chief Stitzel about the large drug bust that happened, and whether or not we would receive a percentage of the value of what was confiscated. Chief Stitzel responded yes we should.

Road Maintenance Department

Mr. Bevan reported the following:

- Trees have been taken down in the cemetery without any damage to stones.
- Six and half tons of gravel was applied to Dredge Road.
- Riley's has will be doing berm work at a cost of approximately \$250.00
- Fox Hollow, Hominy Ridge and Ballentine Pike all need to have gravel laid on the berms, they
 are looking at borrowing a chute to lay the gravel, or looking into the cost of making our
 own chute. Will check out several places.
- Mr. Mark Sanders, neighbor to Mt. Calvary Cemetery, reported he is having trouble with people dumping old flowers and debris over the fence onto his property. Mr. Metzger suggested putting up signs for NO DUMPING.
- F. Motion to approve the FDC 2016 road spraying, total costs approximately \$4800.00:

Discussion concerning the leasing of a new lawn mower:

Received two quotes: JD Equipment and Koenig Equipment

Both were for a one year lease at \$1000.00 year, maximum of 200 hours, purchase option at end of contract. Differences between the two were the size of the deck: 54" or 60", and the type of seat: standard verses suspension. The 54" would be better if they had to mow in the cemeteries, the 60" would be better for mowing larger open areas. Prefers the suspension seat.

Old Business

Mt. Calvary Cemetery – Mrs. Emory gave a report on the situation with the old section of Mt. Calvary Cemetery. We have not heard from the Village of Tremont concerning this matter. Their legal counsel did receive the letter from our prosecutor. Our prosecutor suggests we send Tremont a letter with the date that we will no longer be taking care of the old section, and when we will be sending the cemetery bequest funds to them. Tremont does not owe us anything for our care of the cemetery in the past. We do not owe them any money other than the bequest funds. The road in the cemetery belongs to Tremont. If we want to help with expenses of maintaining the road we need to sign a contract with Tremont and both entities must agree.

H. Motion to send a letter to the Village of Tremont City stating that as of April 20, 2016 the Township will no longer maintain the old section of Mt. Calvary Cemetery, and the bequest funds will be turned over to them:

Old Salt Shed: Need to get quotes on the cost of tearing down and removing the old salt shed.
